3	Software Inclination - RFP seems to be inclined towards customized development. Please confirm that a Standard ERP (COTS) product will be accepted as well	The proposed application should be as per Scope of Work mentioned in the RFP.
4	Implementation Time Frame - They have mentioned that the time frame is 75 days. I think this is too short to implement complete ERP in this time frame. I believe it should be more than 8-9 months Kindly confirm that we can propose our time lines (which would be more realistic)	The bidder may furnish their time schedule as per the format of Table-B of Annexure-XVI of the RFP.
5	Implementation Locations - Please provide locations to be covered for implementation scope or it will be implemented at HQ, Dept. of Civil Aviation, UP	The implementation location will be different departments / divisions at Head Quarter, Department of Civil Aviation, Govt of UP, Lucknow.
6	<b>Training</b> — Please provide number of user to be trained and whether the training will be centralized or decentralized.	The number of trainee would be approximate 25 to 30 and the training will be conducted at Head Quarter, Department of Civil Aviation, Govt of UP, Lucknow.
7	Data Digitization / Migration Do they expect any hard copies or legacy data to be digitized or computerized.	The documents available at Department of Civil Aviation, Govt of UP, Lucknow may be scanned.
